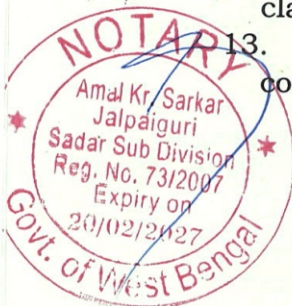
1. That Jalpaiguri Loknath Future Foundation is a registered society under WBSR Act, 1961 and I am the secretary of the said society.

That the Principal and correspondent / manager of the school have individually gone through the provisions contained in the affiliation as examination bye- laws and circular issued by the Board from time to time. The school undertakes to abide by the provisions content in the affiliation and examination bye laws , directions issue from time to time and the law of the land.
9. That the school will ensure compliance of statutory requirements like EPF, ESI and Labour Laws etc. with respect to the school and staff of the school.
