3. That Jalpaiguri Loknath Future Foundation is of Non-Proprietary character.


4. That the School is being run as community service and not as a business and so commercialisation does not take place in the School in any manner whatsoever.

- 8. That the Principal and correspondent / manager of the school have individually gone through the provisions contained in the affiliation as examination bye- laws and circular issued by the Board from time to time. The school undertakes to abide by the provisions content in the affiliation and examination bye laws, directions issue from time to time and the law of the land.
- 9. That the school will ensure compliance of statutory requirements like EPF, ESI and Labour Laws etc. with respect to the school and staff of the school.
- 10. That the school ensure that the building safety, fire safety, water safety, health and hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.
